- (5) information regarding a social, ceremonial, or community event organized or sponsored by an entity other than the governing body that was attended or is scheduled to be attended by a member of the governing body or an official or employee of the political subdivision; and (6) announcements involving an imminent threat to the public health and safety of people in the political subdivision that has arisen after the posting of the agenda.

Amy Madison discussed dates on the PCDC Quarterly Calendar. Discussion and review of the Pflugerville Community Development Corporation Code of Ethics Policy. Presented by Patty Akers, General Counsel, PCDC.

Patty Akers, Counsel for Pflugerville Community Development Corporation, presented and discussed the PCDC current Code of Ethics and also discussed the City of Pflugerville's City Charter. In the PCDC Bylaws, it states that the Code of Ethics is to be reviewed annually by the Board and by the City Council. Part of PCDC's new board member on-boarding process, includes receipt of the Code of Ethics and the member is to sign a statement indicating receipt of this document.

Discussion regarding the Pflugerville Community Development Corporation Fund Reserve and Budget Policy. Presented by Todd Pruitt, CPA, Audit Partner, Pattillo, Brown and Hill, LLP.

Discussion regarding Pflugerville Community Development Corporation's (PCDC) Fund Reserve and Budget Policy. Presented by Todd, Pruitt. Board discussed a contingent reserve for debt service. Todd stated that this really is a minimum fund balance. PCDC will maintain a certain level and if falls below that balance, steps will be taken to restore. Usually a rule of thumb is 25% of debt service is set aside for the minimum fund balance. There is no specific amount set by law. Todd stated that it is prudent in our policy to make clear what exactly is considered debt service.
