Mr. Pruitt presented the PCDC FY19 Annual Audit.

#### **4B.** 2020-8352 Discussion regarding the PCDC 's response to COVID19.

Ms. Madison presented a report on PCDC's activities related to COVID19. Efforts include a weekly roundtable to provide connectivity between local manufacturers on medical supply chain ideas and operations to help them keep producing.

**4C.** 2020-8346 Discussion regarding the Pfluger Pfund, a Small Business Emergency Grant Program to be adminstered by the Pflugerville Chamber. Presented by Shontel Mays, President Pflugerville Chamber.

Ms. Mays informed the Board about the Chamber's Pflugerville Pfund program for local small businesses that will grant up to \$5000 to approved applicants to help during this time. PCDC is contributing a matching grant of \$15K toward the fund.

**4D.** 2020-8347 Discussion regarding a PCDC revolving loan program for local manufacturers. Presented by Rosa Rios Valdez, CEO BLC of Texas.

Ms. Madison and Ms. Vasquez, COO of BCL (presented in place of Rosa Valdez, CEO) informed the board on a possible revolving loan program that could be run by BCL of Texas. Ms. Madison will bring specific detail on the program set up at a future Board meeting.

**4E.** 2020-8344 Discussion regarding a FY2020 High Demand Job Grant for advanced manufacturing training and equipment.

Ms. Madison informed the board regarding progress on the FY20 High Demand Job Training Grant in partnership with Texas Workforce Solutions Capital Area and Austin Community College for \$150,000 to be matched by Texas Workforce Commission after approval of the application. The application will be submitted early next week. This grant application will focus on advanced manufacturing training utilizing our local manufacturing companies and their equipment and locations. Ms. Madison will bring an update in a future meeting.

#### 5. Discuss and Action

#### **5A**. 2020-8357

Discuss and consider action on a First Amendment of the Economic Development Performance Agreement by and between Pflugerville Community Development Corporation and Essentium, Inc.

Ms. Madison presented an Amended Economic Development Performance Agreement (EDPA) for local company, Essentium. The amended agreement would allow for expansion and lease investment instead of 10 additional jobs in FY20.

Mr. Coleman moved to approve the First Amendment of the EDPA Agreement by and between PCDC and Essentium, Inc. Mr. Agnew seconded. Passed 7-0.
