## 1. Call to Order

Ms. Amy Madison announced that the PCDC was recognized and awarded a Certificate of Achievement for Economic Excellence for 2022. This is the eighth year in a roll that PCDC has received this award. The award was presented to Ms. Madison by Carlton Schwab, President, Texas Economic Development Council (TEDC). Ms. Madison also commented that PCDC was awarded a Certificate of Recognition from the "We Hire Vets" program with the Texas Workforce Solutions. PCDC is very proud to have hired a veteran, Ms. Veronica Ramirez, Marketing and Communications Manager. Pursuant to Texas Government Code Sec. 551.0415. a member of the Board or PCDC staff may make an announcement about items of community interest during a meeting of the governing body without having given notice of the subject of the announcement. "Items of community interest" includes:

(1) expressions of thanks, congratulations, or condolence;

(2) information regarding holiday schedules;

(3) an honorary or salutary recognition of a public official, public employee, or other citizen, except that a discussion regarding a change in the status of a person's public office or public employment is not an honorary or salutary recognition for purposes of this subdivision;

(4) a reminder about an upcoming event organized or sponsored by the governing body;

(5) information regarding a social, ceremonial, or community event organized or sponsored by an entity other than the governing body that was attended or is scheduled to be attended by a member of the governing body or an official or employee of the political subdivision; and

(6) announcements involving an imminent threat to the public health and safety of people in the political subdivision that has arisen after the posting of the agenda.
